WOOD COUNTY ADULT DRUG TREATMENT COURT

Wood County Criminal Justice
Department

Goals

Provide tools to participants to maintain a healthy, sober lifestyle.

Provide community opportunities for treatment and engagement to individuals whose crimes are impacted by their substance use.

Increase the number of individuals who remain alcohol and drug free.

Decrease recidivism and increase public safety.

Connect participants with support networks, recovery coaches/sponsors, and individualized case management.



Wood County Drug Court

Requirements include **participation in substance use treatment, random drug testing, on-going appearances before the Judge, case management meetings, and attendance of support groups** (AA, NA, Smart Recovery, etc.).

Participants are also required to obtain employment or pursue educational opportunities, participate in pro-social activities, pay court costs, restitution, and program fees.

There are 5 Phases of Drug Court, with a minimum of 90 days in each phase making the program a **minimum of 15 months**. Phase advancement is based on the accomplishment of goals and program requirements. Participants can expect that advancement through the phases will reduce the amount of supervision while increasing the level of responsibility.

Eligibility

- *Wood County Resident*
- *18 years old or older*
- *Substance Use Disorder*
- *Voluntary Participation*
- *Motivation for Recovery*
- *No prior or current violent felony convictions*
- *No high level drug dealing involvement*

Referral Process

New Charges or Alternative to Revocation (ATR) Referrals

1. *Attorney or Probation Agent sends referral to Wood County Criminal Justice Department.*
2. *Referral is reviewed for preliminary qualifications.*
3. *If qualified, Substance Use Disorder assessment and risk/needs assessment is scheduled to determine eligibility.*
4. *Referral is reviewed by the Drug Court team for final approval.*
