GREAT PLAINS 10' DRILL: The Great Plains Drill is a 10' wide, heavy drill that requires a 70hp tractor. It has three seed boxes; one for legumes and small grass seeds and one for grasses up to peas and a native seed box. The 1 bu. /ft. native grass box effectively meters everything from fluffy native grass mixes to denser seeds, such as brome.

**COSTS:** You must fill out the attached No-Till Drill Operating Agreement and return it with your payment prior to use of the drill. Please submit the drill rental flat fee + acreage fee; if you are unsure of the number of acres you are going to plant with the drill, we will invoice you after your planting for the acreage fee.

**No-Till Drill Operating Agreement**

I agree to the terms and charges for use of the drill/seeder, which includes maintaining the drill and paying for any damages incurred to the drill when it is in my possession. I understand that it is allowed only for use on land which is being used or will be used for soybeans, small grains, rotational grazing, forages, or no-tilling cover crops. Use on wildlife openings and food plots will be at the discretion of the Wood County Land & Water Conservation Department. I agree to compensate Wood County for use of the drill at the required rate before receiving the drill. Payment is due before you will be allowed to use the drill.
